- Project Narrative – Must include in writing a detailed description of the work to be performed.
- Current copy of contractor’s license to be kept with the file
- Current COI must be submitted. A minimum \$1,000,000.00 insurance policy naming Vineyard City as beneficiary.
- Appropriate bonding must be in place. The bond amount will be assessed based on the specifics of the project.
